Welcome to the latest edition of the British Association of Dermatology Biologics Interventions Register (BADBIR) newsletter.

We aim to inform you of the latest developments within the BADBIR study, provide you with information about the study and the staff involved, and to answer any questions or queries you may have.

In this issue, we will show you how many centres are recruiting patients to the register. We are in the process of recruiting centres throughout the UK and Ireland with approved centres in all the mainland UK countries. We aim to recruit 4,000 patients for each biologic therapy, as well as 4,000 patients on standard systemic therapy. The data from these participants will allow us to compare the rates of serious adverse events from our participants receiving biologic treatments.


Our research would not be possible without the help of dermatology teams taking the time to recruit patients and inform us of adverse events. We would like to thank you all for your effort and hard work

### It's not only patients receiving biologics that can join the project...

Our comparison cohort monitors patients on systemic conventional psoriasis therapies (e.g. PUVA, methotrexate, acitretin etc.). We are eager for conventional patients to be recruited — they can be registered within 6 months of them starting any new therapy, even if they have received conventional treatments previously. However, they must never have received biologic therapy.

The payment for registering and following up patients is also the same as registering Biologic patients.

All patients are followed up in the same way: via the dermatology team 8 times, initially every 6 months for the first 3 years and annually up to year 5. Patients will also be followed with their own questionnaires at the same points as the consultant follow-ups:



#### Funding...


Funding is available for the registration, follow-up and data recording of patients. The amounts are:

#### £120 per patient registered

£30 per follow up visit (total number of visits is 8)

The funding is intended as fiscal support for the use of nurse and support staff time on the BADBIR activities.

Many dermatology centres are now becoming involved in the Register. Sites are situated in all areas of the U.K. and we are eager to have as many centres as possible involved.
